**ORDER**  
(CLEAN UP CALENDAR)

**THIS MATTER** came on for hearing before the undersigned Judge of the District Court on \_\_\_\_\_, 20\_\_ on the Court's own motion pursuant to Rule 41 of the NC Rules of Civil Procedure. 7. No other lesser sanction is appropriate to dispose of the case.

**BASED UPON THE FOREGOING FINDINGS OF FACT, THE COURT REACHES THE FOLLOWING CONCLUSIONS OF LAW:**

1. The parties have failed to comply with the Civil Case Management Rules.
2. Pursuant to Rule 41 (b)&(c), NC Rules of Civil Procedure, no lesser sanction than dismissal suffices with regard to the claims for relief which have not heretofore been resolved by Court Order.
3. The claims for relief indicated below should be denied or dismissed with or without prejudice as indicated.
